The Fortye Hall has 20 offices, one lobby vestibule area, two conference/training rooms, and four restrooms with a total of four toilets, 2 urinals, and 4 sinks.

The trash and recycling receptacles are located in the parking lot area between Zenoff Hall and Fortye Hall.


