Bids received from, All American Poly – Bid 2, Envision Industries, Inc., Interboro Packaging Corporation – Bids D and E, Mercury Plastics, Inc., Pueblo Hotel Supply, Waxie Sanitary Supply (Bid 1) and Waxie Sanitary Supply (Bid 2 - Lot 3), Xpedx, a Division of International Paper, are recommended for rejection because they entered an incorrect unit price, failed to submit bids on the Revised Bid Form per Addendums, did not provide samples and Bid Form, samples did not meet specifications, description information in a timely manner, and/or did not bid on all items within lot.
