ROOFING AT CLARK COUNTY FIRE STATIONS 14, 23, AND 24

NEVADA STATE LABOR COMMISSION PWP NUMBER: CL-2013-270

SCOPE OF WORK: At Fire Stations 14, 23, and 24: At main roof area overlay existing roofing with new coverboard and new roofing membrane. At mechanical well roof remove existing roof to decking and provide and install new rigid insulation, coverboard, and roof membrane. At parapet walls remove EIFS and provide and install new sheathing and roof membrane. At sheet metal coping remove existing coping and nailers and provide and install new nailers and new roofing edge termination. Provide and install walkpads to serviceable units, new penetration flashings, and other miscellaneous roof accessories as indicated in drawings and specifications.

ESTIMATED COST: \$365,750 - \$404,250.
