ADDENDUM NO. 5

REQUEST FOR PROPOSAL

1. The RFP opening date of December 16, 2013 at 3:00:00 p.m. **remains unchanged.**

GENERAL CONDITIONS

2. Page 5, Item No. 8 – Evaluation Information, Paragraph 8 – Project Fee, Subsection 8.1, **add** New Subsection f, as follows:
 - f. Per-Patient Cap and Aggregate Cap: For evaluation purposes, the single maximum cost per inmate shall be \$30,000.00 per year and the aggregate maximum cap is \$1,000,000.00 per year. The said cap will remain firm for the five (5) year term of the Contract.

QUESTIONS AND ANSWERS

- Q1. As the contract with the current vendor reflects a per-patient cap and an aggregate cap for offsite services, should vendors assume the current contract terms, ensuring that all bids are comparable based on the same assumptions? A) What is the current per patient cap and the current aggregate cap for offsite services; B) How many cases have exceeded the per-patient cap and by how much for the most recent three years?; C) Has the current vendor exceeded the aggregate cap and by how much for the most recent three years?;
- A1. A) According to Amendment 8 of the current contract, the single maximum cost per inmate, per year, is \$26,807.13. The aggregate maximum cost is \$937,885.45 per each year of the agreement; B) For each of the last three (3) years, CCDC reached the aggregate cost per inmate in the following manner: in 2011, by four (4) inmates; in 2012, by eight (8) inmates; and in 2013, by twelve (12) inmates; C) No, the current provider is only responsible for costs up until the cap, thereafter the associated costs are those of CCDC. Further, CCDC has incurred costs associated with inmate expenses over the aggregate cap amount for the last three (3) years.

Except as modified herein, all other Bid specifications, terms and conditions shall remain the same.
