DESERT INN AND LAMB RECONSTRUCTION

NEVADA STATE LABOR COMMISSION PWP NUMBER: CL-2014-85

This is a Fuel Tax Indexing funded project. On October 1, 2013 the Board of County Commissioners approved and adopted by resolution to support local hiring and develop opportunities for local Nevada residents to become employed on planned fuel tax indexing projects and identify workers and local companies, especially those that support minority and women-owned businesses.

SCOPE OF WORK:

Desert Inn between Paradise Road and Mojave Road along with Lamb Boulevard from Owens Avenue to Las Vegas Boulevard are scheduled to be reconstructed. The work to be performed under this contract consist of excavating 8" of existing material on various locations along Lamb Boulevard and Desert Inn Road and replacing 2" of Type II, 5" of Dense Grade and 1" of UTACS. Locations along Desert Inn will also receive a 1" cold plane and overlay with 1" UTACS. Locations along Lamb will also receive a cold plane and overlay. In addition, this contract consists of pavement widening, bringing sidewalk ramps up to ADA Standards, removing and replacing spandrels/cross gutters where indicated, adjustment of manholes and water valves, removing and replacing pavement markings, striping and traffic signs, and other related items of work within the unincorporated area of Clark County, Nevada.

ESTIMATED COST: \$6,500,279 - \$7,222,532.

Bidders and other interested parties are invited to attend the Bid opening.
