SCOPE OF WORK: Demolition of existing pilaster between (rear) apparatus bays one and two, creating a larger opening; demolition of existing wall at EMS Office (salvage existing millwork for reinstallation); provision/installation of a construction barricade per the architectural and structural drawings, provision/construction of EMS Office wall with a new configuration; provision/installation of new 4-panel door with structural steel at the apparatus bay opening; provision/installation of new door, ceiling tiles, light fixtures, and finishes at the EMS Office; reinstallation of millwork at EMS Office.

ESTIMATED COST: \$300,000 - \$340,000.
