WELCOME TO LAS VEGAS SIGN PARKING LOT IMPROVEMENTS

NEVADA STATE LABOR COMMISSION PWP NUMBER: CL-2014-275

SCOPE OF WORK: This project is to expand the parking lot located in the median island on Las Vegas Boulevard between Russell Road and Sunset Road for the "Welcome to Fabulous Las Vegas" sign. The expansion is to increase the accessibility to the sign (which is protected on the U.S. National Register of Historic Places) and renovate to provide additional parking spaces with associated appurtenances. Improvements include providing additional paving in the median for the new parking spaces and for the relocated exit driveway. The existing pavement to remain in place is to receive a one-inch UTACS overlay. A new traffic signal, LED streetlights, crosswalks, bus turnout, signs and associated pavement markings are to be installed. New ground mounted and wall mounted decorative pedestrian containment fencing is to be constructed. Landscape renovations include a palm tree relocation and modified irrigation system. The existing overhead power to the sign is to be relocated underground.

ESTIMATED COST: \$1,343,929. - \$1,493,254.50.
