On September 3, 2014 a Notification of Intent to award was sent to you advising that Boot World, Inc. dba Boot World/KM Shoes would be recommended for award for Lots 1, 2, 5, and 6. After this date it was determined that Boot World, Inc. dba Boot World/KM Shoes made a mistake in its bid calculations. Its bid has been rescinded.

The bid received from Sumar, Inc. dba Desert Birkenstock is being recommended for rejection because it failed to meet the minimum bid requirement.

In accordance with the Protest Clause in the referenced Bid document, all Bidders have five business days from receipt of this notification to submit a formal written protest to the Purchasing Analyst. The final date to receive a protest is September 15, 2014.
