GOVERNMENT CENTER PARKING LOT REHABILITATION

NEVADA STATE LABOR COMMISSION PWP NUMBER: CL-6014-302

SCOPE OF WORK: The base scope of Work consists of cleaning, preparation, and maintenance of approximately 901,000 square foot asphalt concrete parking lot, which consists of, but is not limited to, complete crack mitigation, placement of a resurfacing slurry seal as specified, installation of new pavement striping and markings, and repainting of all existing curbs. Access to each phased work area shall be limited to weekend days only throughout the contract duration. The owner anticipates the need for multiple and consecutive work shifts throughout each weekend phase. The designated work days allowed by this agreement are Friday through Monday beginning at 6:00 p.m. on Friday evening and ending 4:00 a.m. on Monday mornings.

The work also includes one Additive Alternate as described in the project drawings, technical specifications, and Division One section 01 23 00 of the project manual.

ESTIMATED COST: \$496,000 - \$526,000.
