SCOPE OF WORK: The work to be performed under this contract consists of excavating 4" of existing material on Spencer Street between Windmill Lane and Robindale Road, and replacing with 4" of Dense Grade. Locations along Spencer Street between Robindale Road and Warm Springs Road will consist of Type II Slurry or full depth pavement reconstruction (see plans for improvement type locations). Work performed along Serene Ave, from Spencer Street to Eastern Ave, consists of excavating existing material and replacing with 4.5" of Dense Grade and 1" UTACS. In addition, this contract consists of curb and gutter, grate inlet, drop inlet, fencing, reinforced concrete pipe, concrete pad, concrete collars, traffic signal modifications, removing and replacing manhole, manholes, adjustment of manholes and water valves, removing and replacing pavement markings, striping, and other related items of work within the unincorporated area of Clark County, Nevada.

ESTIMATED COST: \$1,856,325. - \$2,062,584.
