ADDENDUM NO. 2

INVITATION TO BID

1. The bid opening date of January 22, 2015 at 3:00:00 p.m. **remains unchanged.**

SCOPE OF WORK

2. Page IV-2, Item 6, Security Staffing Tiers, **delete** and **replace** with below. The changes are shown in bold.

"The following definitions serve as a guideline only. Owner reserves the right to determine the tier to be used at all facilities on a case by case basis.

A. Tier 1 – Armed Security Officer

Indicated for all facilities for manning metal detectors under the direction of a Law Enforcement Officer (**Deputy Marshal**) or **Tier 2 Armed Security Guard**. Security asset of choice for County Facilities during business hours or whenever County employees are present. Distinguished from the Watchman category by advanced training and demonstrated skill in dealing with people and verbally diffusing confrontations, and by the ability to project an authoritative presence.

B. Tier 2 – Armed Security Officer (Lead)

Indicated where there is an adversarial public contact in a facility equipped with a metal detector, and Law Enforcement Officer is not an available option, and at any time when specific, credible threats have been received. **Distinguished from the Tier 1 category (above) by advanced training, supervisory or lead experience, the ability to work independently, with demonstrated skill in dealing with people and verbally diffusing confrontations, and the ability to project an authoritative presence."**

C. Tier 1 and 2

Tier 1 and 2 Security officers provided under this contract will be licensed and qualified to carry firearms. The requirement to actually carry firearms at any given post will be solely at the discretion of the County, and may change at any time, and any number of times, for the duration of this contract. Both Tier 1 and 2 are required to carry a full duty belt, to include firearm, secondary weapons (baton, OC spray), handcuffs, and flash light. It is strongly recommended to wear protective/ballistic vests but it is not a requirement."
