#### **SEARCHLIGHT JUSTICE COURT: SECURITY AND CASEWORK IMPROVEMENTS**

SCOPE OF WORK: This work shall include selective demolition, architectural woodwork, casework, bullet resistant glazing framing and accessories, clerk counter, ADA compliant modifications to existing restrooms, new doors, floor coverings and wall paint. Any electrical changes are minor relocations of existing outlets, not requiring electrical design. Existing plumbing has minor changes in relocating fixtures. Mechanical systems are unaffected. The occupancy and usage of the building is unchanged. The capacity of parking facilities that now services the building are unaffected by this work.

ESTIMATED COST: \$104,000 - \$109,200.
