### INVITATION TO BID

**SUNSET ROAD, JONES BOULEVARD TO DECATUR BOULEVARD**

NEVADA STATE LABOR COMMISSION PWP NUMBER: CL-2015-137

**SCOPE OF WORK:** The project consists of roadway improvements on Sunset Road between Jones Boulevard to Decatur Boulevard and on Lindell Road between Sunset Road and Teco Avenue. Improvements include plantmix bituminous pavement for a minimum of (1) travel lane in each direction, drainage swales, permanent striping, permanent signing, and construction of concrete drop inlets.

Improvements also include an approximately 120-foot wide concrete structure over the existing Lower Blue Diamond Channel. The approximately 20-foot wide x 12-foot high existing concrete lined channel will have a reinforced concrete slab placed on top of the existing channel walls. This will modify the existing channel into a box culvert. Fill soil will be placed over the top of the new slab. Headwalls and barrier rails will be constructed at each end of the channel crossing.

ESTIMATED COST: \$820,476 - \$911,641
