NOTE: This is a Federally Funded Project governed by State and Federal Wages.

SCOPE OF WORK: The work to be performed under this contract is for freeway and incidental improvements to the Southern I-215 Bruce Woodbury Beltway from approximately Las Vegas Boulevard to Warm Springs Road and along State Route 171 (Airport Connector) from approximately Sunset Road to I-215.

The improvements include construction of a direct connection ramp and bridge structure from southbound Airport Connector to eastbound I-215, widening of the Southern I-215 Bruce Woodbury Beltway for auxiliary and ramp lanes and realignment of the eastbound I-215 off-ramp to Warm Springs Road. Other associated improvements include widening of the existing westbound I-215 bridge over the Airport Connector, a new bridge structure for the realigned eastbound Warm Springs off ramp, drainage structures, sound wall and concrete retaining wall structures.

ESTIMATED COST: \$53,000,000 - \$59,000,000.
