SPECIAL PROVISIONS

SECTION 100 – SPECIAL PROVISIONS

2. Subsection 100.01, Location and Scope (page 100-1)

Replace the subsection with the following:

The intent of this contract is to supplement and assist in the work currently being performed by Clark County Public Works (CCPW). The work to be performed under this contract consists of modifications, installations, and maintenance of all County-maintained traffic signal systems, flasher systems, and fiber optic infrastructure. Work involves removal, replacement and installation of various items related to the traffic signal, flasher, and intelligent transportation systems, with mostly County supplied materials.

The Owner will issue Work Order(s) as needed for any items listed in the bid schedule. Scope and time allowed on each work order will vary from work orders to work orders. All work shall be performed during the hours in accordance with the County Code, Title 30 "Unified Development Code", Section 30.21.100 "Time Restrictions on Work in Streets", unless otherwise specified in the Work Order.

SECTION 107 – LEGAL RELATIONS AND RESPONSIBILITY TO THE PUBLIC


3. Subsection 107.07.05, Traffic Control Measurement and Payment (page 107-4)

Add the following:

For traffic control that requires lane closures in roadways under the jurisdiction of other agencies, Contractor shall also submit temporary traffic control plans to the agency as required. No separate payment will be made.

Except as modified herein and in Addendum 1, all other bid specifications, terms, conditions and special provisions shall remain the same.
