SCOPE OF WORK: This project includes installation of fiber optic cable on Durango Drive from Warm Springs Road to Sahara Avenue and Tropicana Avenue from CC-215 to Rainbow Boulevard, replacement of pull boxes, installation of pull boxes, and installation of 25-pair interconnect cable. Project also includes CCTV cameras, controllers, video encoders, and other miscellaneous improvements as shown on plans.
