SCOPE OF WORK: The "Project" of which the "Work" of the Contract is a part titled Pearson Park: Track & Field Renovation and is located at 1625 West Carey Avenue, Las Vegas Nevada. The "Work" is described in the Project Drawings and Divisions 1 through 48 of the Project Manual.

The Work consists of the construction of approximately a 1,600 square foot, single story Concessions/Storage facility, Selective demolition, renovation and replacement of a 400m running track, shotput, discus with cage, high jump, long/triple jump, pole vault, fencing, bleachers and pressbox.

Construction includes adjacent off-site work, site work, landscape and irrigation, athletic track and equipment, and a complete building using materials noted on Drawings and specified herein.

ESTIMATED COST: \$2,232,500 - \$2,467,500.
