This is a Fuel Revenue Indexing funded project. On October 1, 2013 the Board of County Commissioners approved and adopted by resolution to support local hiring and develop opportunities for local Nevada residents to become employed on planned fuel tax indexing projects and identify workers and local companies, especially those that support minority and women-owned businesses.

SCOPE OF WORK: Improvements to Rainbow Boulevard from Cactus Avenue to Blue Diamond Road include hot mix asphaltic concrete pavement, mill and overlay, raised medians with left turn lanes, storm drain improvements and adjustments, curb and gutter, pavement markings, signage, and other necessary appurtenances to make a good and serviceable project providing one travel lane in each direction.

ESTIMATED COST: \$4,441,960 - \$4,935,511.
