SUNSET PARK: SOUTHWEST PARKING LOT REHABILITATION

NEVADA STATE LABOR COMMISSION PWP NUMBER: CL-2016-45

SCOPE OF WORK: The "Project" of which the "Work" of the Contract is part titled Sunset Park: Southwest Parking Lot Rehabilitation and is located adjacent to Eastern Avenue at 2601 East Sunset Road, Las Vegas, NV 89120. The "Work" is described in the Project Drawings and Divisions 1 through 48 of the Project Manual.

The project involves, but is not limited to, bituminous crack sealing, Type I Slurry Sealing, installation of pavement markings for crosswalks, handicap parking pavement markings, signage and parking bumpers, sawcutting of pavement, select areas of full depth Asphaltic Concrete pavement / base course removal and replacement, concrete curb removal and replacement with 'L' type curb inclusive of paint, rehabilitation of concrete light pole bases, construction of new concrete sidewalks and driveways, and work as noted in the project plans.

ESTIMATED COST: \$266,000 - \$294,000.
