#### **STEPHANIE CAMPUS AUCTION YARD TRAILER DEMOLITION & REPLACEMENT**

SCOPE OF WORK: The "Project" of which the "Work" of the Contract is a part titled "Stephanie Campus, Auction Yard: Trailer Demolition & Replacement" and is located at 4320 Stephanie St. near Flamingo Rd., Las Vegas, Nevada. The "Work" is described in the Project Drawings and Divisions 1 through 48 of the Project Manual.

The Work consists of the site work construction to accommodate an approximately 10,265 10,265 square foot, single story modular building housing office with counter and restroom.

Construction includes the, demolition of an existing 12 foot x 33 foot modular building, site clearing, trenching and excavation, Protection of hose bib, underground piping, site lighting, and temporary power. Construction of new foundations, extension of utilities, grading in preparation for new 12 foot x 56 foot modular building, concrete slab on grade patio, cmu block stairs, metal railing, asphalt ADA route from street and new asphalt ADA parking stall with pavement markings and signs.

ESTIMATED COST: \$123,500 - \$136,500.
