**BERMUDA ROAD, PARADISE ROAD, MCLEOD DRIVE, CABANA DRIVE RESURFACING AND  
TWIN AVENUE RESTRIPIING**

NEVADA STATE LABOR COMMISSION PWP NUMBER: CL-2016-70

SCOPE OF WORK: Project improvements generally consist of resurfacing various roadways by either a pulverize and pave method or a 1-inch cold planing and resurfacing with 1-inch ultra-thin asphalt concrete surface (UTACS) overlay. Improvements will include pavement reconstruction, median re-configuration, sidewalk, sidewalk ramp and curb and gutter reconstruction; valve and manhole adjustments, loop detection installation and replacement, and roadway striping, signing, and other associated appurtenances. Project limits include the following portions of roadways: Bermuda Road from Hidden Well Drive to Sunset Road; McLeod Drive from Tropicana Avenue to Flamingo Road; Cabana Drive from Flamingo Road to Vegas Valley Drive ; Paradise Road within UPRR right-of-way north of Pilot Road; Twain Avenue from Nellis Boulevard to Cabana Drive.

ESTIMATED COST: \$3,931,200 - \$4,368,000.
