Per the suggested changes to the code, dumpsters on streets that are not fully improved can be left within 12 feet of the edge of the paving and have reflectors on all 4 sides. A suggestion was made of having about 6 foot setback in Goodsprings. The proposed ordinance changes will be completed sometime in September and will be presented to the Board of County Commissioners.
