## **COMMUNITY CONCERN**

Debbie Dauenhauer, Executive Director of the Southern Nevada Transit Coalition (SNTC), was present to discuss the Silver Rider transportation services. The bus made its first run January 13, 2014 from Sandy Valley and will continue to run Monday and Friday of each week. Reservations are needed 24 hours in advance and for Monday service, the reservation must be made on Friday. Passengers will be picked up at the Goodsprings Community Center at 8:30 a.m. and dropped off at 4:00 p.m. The fee is \$8.00 round trip. The fare for senior citizens and disabled riders is donation based, if the rider is registered with Silver Rider. An 8 passenger bus is currently being used, but that may be increased to a 14 passenger bus if needed. Silver Rider also provides connections in Las Vegas to the VA hospital and clinics. Bill Newsome is the driver and he has all the forms that are needed. Silver Rider will also do organized trips for 60 years and older citizens. A letter of support for continuation of Federal Administration for funding was written and approved by CAC. The letter was signed by the CAC Chair and given to SNTC. Beisecker/Warren (5-0)
