PUBLIC COMMENTS

Noel Sheckells brought up the idea of a Goodsprings parade, including vendors. It was suggested for August. He was hoping the Historical Society would sponsor it. Permits will be needed for parade and vendors. There should be entry fees and we will need prizes for winners. Costs will include: trophies, prizes, printing, permits, Metro, television and radio spots, liability insurance (approximately \$800). It could cost around \$2,000 to put on a parade. Parking and parade route need to be figured out. It was suggested to start the parade by Monica's house to George Handy's then down Spring Street ending at the bar. Suggestions for booths and vendors are: Boy Scouts, Historical Society, Pioneer Saloon, private individuals, artists, craft people, BBQ, car clubs, VFI fire truck, Sandy Valley yacht club, and drill team. Ruth Rawlinson was asked if she would spearhead the project. Monica said she would help and Julie Roddham said she would help too.

Julie Roddham has a question regarding the outdoor restrooms at the bar. It looks like there is piping going down to the septic tank. There are no permits for them. Noel will check into it.
