There is open code enforcement for the Kiddy property. February 17, 2012 it was sent to the District Attorney. There are two active permits, one for the wall and one for the house and grading.

The sale of the Henderson BLM property was already in process, it is not new money. They have already started funding money to underserved communities.

Kern River Gas Pipe Line is building a 9" lateral from north of Goodsprings to Brite Source Energy Hidden Hills Solar Generating System. Drew Smith, Callie Butcher, Scott Miles, and Dave Dahl were present to talk about the project. There are two 250 megawatt solar thermal power plants. They should bring about \$1,000,000 revenue into Clark County. It should take about 1 year to build the project. There are open houses in January and February.
