1. **UC-1004-14 – THOMPSON, JR., HAGAN, ET AL: USE PERMITS** for the following: 1) reduce the minimum lot area for a residential boarding stable; 2) allow a residential boarding stable without a principal dwelling; 3) reduced setbacks; 4) waive landscaping; and 5) allow accessory agricultural buildings without a principal structure on a total of 3.3 acres consisting of 6 lots in an R-E (Rural Estates Residential) Zone. Generally located on the west side of Fairhaven Street, 970 feet north of Vegas Drive within the Lone Mountain Planning Area. LB/pb/ml (For possible action)
2. **VS-0001-15 – HOMANSKY, EDWIN PHILIP TRUST, ET AL: VACATE AND ABANDON** a portion of right-of-way being Rebecca Road located between Deer Springs Way and Centennial Parkway within Lone Mountain (description on file). TC/dg/ml (For possible action)
3. **WS-1012-14 – ELVA TRUST: WAIVER OF DEVELOPMENT STANDARDS** to increase building height for a single family residence on 1.0 acre in an R-E (Rural Estates Residential) (RNP-I) Zone. Generally located on the east side of Grand Canyon Drive, 200 feet north of Kraft Avenue within Lone Mountain. LB/gc/ml (For possible action)
