12.04.230 of the Clark County Code to include the Mt. Charleston communities in Kyle Canyon and Lee Canyon as areas of unincorporated Clark County where it is illegal to discharge a firearm, as follows:

Title 12.04.230

It is unlawful to willfully discharge any pistol, firearm, air gun, musket or instrument of any kind, character or description which throws a bullet or missile of any kind for any distance by means of the elastic force of air or any explosive substance within that area legally described.....

Moving forward, if the TAB approves this directive, staff will work on a boundary map to encompass the communities of Kyle Canyon and Lee Canyon and will bring that map back to the TAB at a subsequent meeting. Once the boundary map is approved, a public hearing item will be placed on the Board of County Commission agenda to amend Title 12.04.230 to include the new boundary map.
