1. **WS-0528-12 (ET-0121-14) – WMBX, LLC:**
WAIVER OF DEVELOPMENT STANDARDS FIRST EXTENSION OF TIME to review to increase the area of temporary wall signs.
DESIGN REVIEW for wall signs in conjunction with an existing extended stay hotel on 1.7 acres in an H-1 (Limited Resort and Apartment) Zone in the MUD-1 Overlay District.
