## How do I see Inspection History?

- From the Building and Fire Prevention Department Home page, go to Customer Reports, and then select Inspection History



- Click on the Inspection History link (please note the permit number entry format instructions on the page)

Clark County Building Department is dedicated to providing our construction and development customers with state-of-the-art permit management, plan review, and inspection services to enhance the built environment.



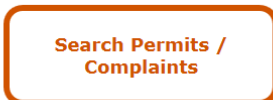
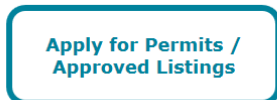

## How do I see outstanding inspection conditions?

- ON PERMITS ISSUED AFTER JANUARY 2018 ONLY, after an inspection type is selected, the lower right portion of the scheduling screen will display all outstanding conditions, and what inspection is conditional on these inspections (i.e. Finished Floor

Elevation – Prior to Framing, Water Clearance – Prior to Final). If the permit was issued prior to January 2018, the conditions will only display as an error message if you attempt to schedule an inspection that is stopped by an un-met condition (I.e. water, sanitation, finished floor certificate, etc.)

## How do I see inspection results?

- Inspection results with inspector comments can be seen in Citizen Access Portal, if you are logged in AND associated to the permit. Locate the number, select it and scroll down to the Inspection header. Click on View Details to see all notes.
