Permit & Plan Review Fees Schedule & Associated Valuation Cost Factors Building Permit Guide

Part I. General Information

The following Building Permit & Plan Review Fees Schedule & Associated Valuation Cost Factors Guide has been established utilizing Table 3-A of the Clark County Building Administrative Code (22.02.390). It is to be utilized to:

- I. Determine building and swimming pool/spa permit and plan review fees as authorized under Section 22.02.345 (A) & (B) of the Clark County Building Administrative Code.
- II. Determine zoning plan review fees as authorized under Section 22.02.345.

In addition to Table 3-A, the Building Valuation Cost Factors are included as a reference. These cost factors are utilized as a basis for determining the total value of construction as authorized under Section 22.02.345 (A) of the Clark County Building Administrative Code.

Part II. Example Calculation of Building & Plan Review Fees Utilizing the Fees Schedule

NOTE: Actual calculations for project valuations less than \$100,000 are provided on the fees schedule. The following example can be utilized to determine fees for project valuations exceeding \$100,000.

EXAMPLE TOTAL PROJECTION VALUATION: \$753,000

STEP 1: Locate \$700,000 in the “Valuation” column.

STEP2: Find the corresponding amount from the “Permit Fee” column (\$2,297.40).

Part III. Other Fees Due at Time of Permit Issue (as applicable):

- M.S.H.C.P. Mitigation fee: \$550 per acre, plus \$50 administration fee for commercial or \$25 administration fee for residential.
- RESIDENTIAL CONSTRUCTION TAX: (dwellings only) \$.36 per living sq. ft. - maximum \$1,000 per dwelling.
- STATE WATER IMPACT FEE: Commercial/Industrial using five (5) acre feet or more of water per year.
- TRANSPORTATION TAX: Commercial/industrial \$.80 per sq. ft. or \$800 per dwelling unit.
