



**Clark County Department of Building Fire Prevention Bureau
Application, Permit and Inspection Changes for the New
IFC Fire Code**

Effective July 5, 2011

With the adoption of the International Fire Code (IFC) by the Department of Building Fire Prevention Bureau (DBFPB), permit names have changed, permit names have expired, and new permits have been adopted. In order to address these changes, the DBFPB computer system has been updated. There are new and changed permit names, new and changed application names, and new associations between permits and applications.

New Permit Application names

Several new permit applications are added to address the IFC requirements, as follows:

Application Names that Have Changed

The IFC has different names for several permits than the UFC did. Also, application names are modified to address how IFC addresses permits. Although requirements stay the same, the application names did not. The changed application names are as follows:
