On January 16, 2014, the U. S. Department of Labor, Bureau of Labor Statistics released its report on the increase in the Consumer Price Index for the calendar year 2013. Pursuant to applicable county and municipal codes, franchise fees will increase by the change in annual average CPI for All Items on April 1, 2014, maximum charges for service will increase by the change in annual average CPI for Medical Care Services and will be effective as of February 1, 2014, and penalties will remain the same.
