Instructions for a Business License Application for a Medical Marijuana Support Business

Any person wishing to operate a business whose purpose is to provide ancillary support to Medical Marijuana Establishments (MME) or the Medical Marijuana industry at large must file an application for a Clark County Business License in order to operate within the unincorporated areas of Clark County. A complete Application Form and other requested documents and information must be submitted for review by the Department of Business License. Such businesses include, but are not limited to: MME-to-MME product transportation services, cannabis-related media outlets (magazines and other publications, etc), MME business consulting services, and Medical Marijuana patient consulting services.

The following instructions are intended to aid the Owner or Operator of the proposed Medical Marijuana Support Business in completing the Application Form and providing required information and documents to be submitted to the Department at:

1. Complete a Business License Application Form.
2. Complete a Financial Questionnaire.
 - Section 1 must be completed for the Medical Marijuana Support Business related to this application.
 - Section 2 must be completed for each individual owner, officer, or board member with an ownership percentage of 10% or higher, as well as other individuals as requested by the Department.

- Section 3 is only required to be completed if a separate entity (non-individual) or business contributed capital for the business.

3. Complete the Ownership Disclosure Form listing all individuals with any ownership interest in the business and their percentages of ownership. The total percentage must equal 100%.

4. Provide a detailed organizational chart.

5. Provide a detailed description of the proposed Medical Marijuana Support Business.

Upon receipt of the Application and information required in #1 through #5 above, the Department of Business License will begin processing your application. The Department may request an FBI background check for any and all applicants during this process.

Once all public safety inspections have been performed and the applicable agencies have signed off that the applicant is in compliance with the Code and regulations, the Department will schedule a Code Conference with the applicant to review the requirements and provisions of the County Code that may affect the applicant and the operation of the Medical Marijuana Support Business. At the Code Conference, the applicant must make available for review by the Department the Business Plan for the Medical Marijuana Support Business. The Business Plan will not be retained by the Department.

NOTICE: No business may be conducted until a Clark County Business License has been approved and issued by the Department.

APPLICATION FEE

The Application for a Medical Marijuana Support Business License must be accompanied with the application fee as follows:

Fees for Medical Marijuana Support Business: \$45 application fee + semiannual gross revenue fee (see schedule of fees below)
