- F. All plans or maps must be accurate and drawn to scale. Please fold plans to the 9"x12" standard for submittal (rolled plans will not be accepted).
- G. Please provide 2 paper copies of each item and 18 CD's (not DVD's) total with documents in a PDF format.
- H. See Title 30.80 for applicable fees. Exact payment only in the form of cash, check, or money order. Make payable to "Clark County".
- I. See Clark County Fire Department *Hazardous Materials Systems Guidelines*, NRS, & NAC.
- J. Landscape or pedestrian realm plans.
- K. Required in Mixed Use Overlay Districts only.

Pre-Submittal Filing Package. The *Pre-Submittal Filing Package* must be submitted no later than the pre-submittal filing deadline shown on the *Nonconforming Zone Change and Implementation Schedule and Pre-Submittal Conference Schedule*. After the close of any pre-submittal deadline (usually the 2nd working day (Tuesday) after the deadline), staff will call the applicant with the exact date, time, and location of the pre-submittal conference (two dates per deadline are already established on the schedule).

Nonconforming Zone Changes will follow the remainder of this schedule for subsequent application filings and required meetings. All other subsequent land use applications will be submitted as shown on the *Land Use Applications Submittal Deadlines* required for all other application types (*appointment required*).
