



# EARLY VOTING / IN-OFFICE VOTING PROCESS

June 4, 2013 Municipal General Election

*Henderson, Mesquite, and North Las Vegas' Ward 1 Only*



Overview: The 14-day early voting period is May 18 (Saturday) to May 31 (Friday). In addition, the City of North Las Vegas will conduct "In-Office Voting" on May 15 - 16 (Wednesday - Thursday). Only voters registered within the [boundaries](#) of Henderson, Mesquite, or North Las Vegas' Ward 1 may vote before Election Day and only at an early voting site within their own City. Locations include shopping malls, super-markets, libraries, and community centers. [Early voting schedules](#) are in sample ballots, newspapers, and on the [Internet](#). **Voters registered in unincorporated areas of Clark County do NOT participate in Municipal Elections. Additionally, Boulder City and the City of Las Vegas will not have Municipal General Elections in 2013** (see [Facts and Figures](#), page 2, for details). Login to "[Registered Voter Services](#)" on the Clark County Election Department's home page to find out if you are eligible to vote in the June 4, 2013 Municipal General Election.

Voting Machines: All polling places are equipped with [electronic touch-screen voting machines](#). These machines include a voter verifiable paper printout of each ballot. The printout stays with the machine. The machines provide [Spanish](#), [Filipino \(Tagalog\)](#), and English ballots and instructions.

Municipal General Election Voting: Candidates who receive the most votes in a General Election are elected to office. You may vote for all [offices](#) on the ballot for your precinct, regardless of your party affiliation. Municipal Elections are nonpartisan, meaning candidates' parties will not appear on the ballot. Election rules and offices up for election vary by City. No Write-Ins: [Nevada Revised Statute \(NRS\) 293.270](#) prohibits write-in candidates.

Early Voting Process:

- Upon arriving at the site, your voting eligibility and signature will be verified before you are allowed to vote. The election Clerk will announce your name, as required by Nevada law ([NRS 293.285](#)).
  - *NOTE: It is always a good idea to bring picture identification with you when you vote.*
- Computers at each site connect to the Election Department's centralized voter files. After the verification process, the Clerk will immediately update your record, thus preventing anyone from voting twice.
- You will then receive an activation card to take to a voting machine.
- Insert the activation card into a voting machine to activate it for your specific precinct and [vote](#).
- When you finish voting, immediately return the activation card to an election official.

Early Voting Turnout: Daily early voting turnout (total voters per site) will be updated on the [Internet](#) each night between around 9:00 p.m.

Results Tabulation: Tabulated results are not available until after 7:00 p.m. on Election Day and are on the Clark County Election Department's [Internet](#) site or [TV channel 4](#).
