Election Rules	<ul style="list-style-type: none"> ● Nonpartisan Elections ● Boulder City will NOT conduct Municipal Primary or General Elections in 2013, See the rules below for details. ● A Primary Election is held only if more than double the number of candidates than there are offices or seats up for election file to run. Two Council Member seats were up for election and only two candidates filed for those seats. Those two candidates were declared elected. ● No contests or questions will be available to vote upon in a Boulder City Municipal Primary or General Election, 	<ul style="list-style-type: none"> ● Nonpartisan Elections ● In the 2013 General Election, all Henderson voters may vote for 1 candidate in the Municipal Court Judge, Department 1 contest. ● In the Primary Election, if a candidate receives 50% plus one of the votes (majority), he/she is declared elected and the office will not appear in the General Election. Accordingly, candidates for Mayor and Council Ward III were declared elected in the Primary Election. ● In the Primary Election, for each seat or office, if no candidate receives a majority of votes, the top 2 candidates (receiving the most votes) per office or seat proceed to the General Election ballot. ● In the General Election, the candidate(s) receiving the most votes is elected to office. 	<ul style="list-style-type: none"> ● Nonpartisan Elections ● Las Vegas will NOT conduct a Municipal General Election in 2013 because for each contest on the April 2, 2013 Municipal Primary Election ballot a candidate received a majority of the votes and was declared elected to office, per the rules below. The offices up for election in 2013 were City Councilman for Wards 2, 4, and 6. ● In the Primary Election, if a candidate receives 50% plus one of the votes (majority), he/she is declared elected and the office will not appear in the General Election. ● In the Primary Election, for each seat or office, if no candidate receives a majority of votes, the top 2 candidates (receiving the most votes) per office or seat proceed to the General Election ballot. 	<ul style="list-style-type: none"> ● Nonpartisan Elections ● In the 2013 General Election, all Mesquite voters may vote for up to 2 City Council candidates (at large) out of a total of 4 candidates. ● In the Primary Election, if a candidate receives 50% plus one of the votes (majority), he/she is declared elected and the seat will not appear in the General Election. Accordingly, 1 candidate for City Council was declared elected in the Primary. ● The top vote getters from the Primary Election that equal double the number of seats up for election will proceed to the General Election (except for any candidate who received a majority of the votes in the Primary and was declared elected). ● In the General Election, the top 2 vote getters will be elected to office. 	<ul style="list-style-type: none"> ● Nonpartisan Elections ● In the 2013 General Election, North Las Vegas voters in Council Ward 1 may vote for 1 candidate in the Council Ward1 contest. Voters may only vote in City Council contests for the Ward in which they are registered to vote. ● In the Primary Election, if a candidate receives 50% plus one of the votes (majority), he/she is declared elected and the office will not appear in the General Election. Accordingly, candidates for Mayor and Council Ward 3 were declared elected. ● In the Primary Election, for each seat or office, if no candidate receives a majority of votes, the top 2 candidates receiving the most votes per office or seat proceed to the General Election ballot. ● In the General Election, the candidate receiving the most votes is elected to office.
