



EARLY VOTING / IN-OFFICE VOTING PROCESS

April 7, 2015 Municipal Primary Election



Overview: The 14-day early voting period is **March 21 (Saturday) to April 3 (Friday)**. In addition, the City of North Las Vegas will conduct "In-Office Voting" from March 18 (Wednesday) to March 19 (Thursday). Only voters registered within the specific boundaries of Henderson, Las Vegas, or North Las Vegas may vote before Election Day and only at an early voting site within their own City. Locations include shopping malls, super-markets, libraries and community centers. [Early voting schedules](#) are in sample ballots, newspapers and on the [Internet](#). **Voters registered in unincorporated areas of Clark County do NOT participate in Municipal Elections. Additionally, Mesquite will have no elections at all in 2015 because it will consolidate its elections with the 2016 Federal/State elections and Boulder City will not have a Primary Election in 2015** (see [Facts and Figures](#), page 2, for details). Voting Machines: All polling places are equipped with [electronic touch-screen voting machines](#). These machines include a voter verifiable paper printout of each ballot. The printout stays with the machine. The machines provide [Spanish](#), [Filipino \(Tagalog\)](#), and English ballots and instructions.

Municipal Primary Election Voting: A Primary Election is a preliminary (nominating) election to select, when necessary, candidates who will run in the General Election contests. You may vote for all [offices](#) for your precinct, regardless of your party affiliation. Municipal Elections are nonpartisan, meaning candidates' parties will not appear on the ballot. A candidate may be declared elected in the Municipal Primary Election if he or she receives a majority of the votes. Election rules and offices up for election vary by City. No Write-Ins: [Nevada Revised Statute \(NRS\) 293.270](#) prohibits write-in candidates.

Early Voting Process:

(NOTE: You may vote only at a site located within the City in which you are registered to vote)

- Upon arriving at the site, your voting eligibility and signature will be verified before you are allowed to vote. The election Clerk will announce your name, as required by Nevada law ([NRS 293.285](#)).
 - *NOTE: It is always a good idea to bring picture identification with you when you vote.*
- Computers at each site connect to the Election Department's centralized voter files. After the verification process, the Clerk will immediately update your record, thus preventing anyone from voting twice.
- You will then receive an activation card to take to a voting machine.
- Insert the activation card into a voting machine to activate it for your specific precinct and [vote](#).
- When you finish voting, immediately return the activation card to an election official.

Early Voting Turnout: Daily early voting turnout (total voters per site) will be updated on the [Internet](#) each night between around 9:00 p.m.

Results Tabulation: Tabulated results are not available until after 7:00 p.m. on Election Day and are on the Clark County Election Department's [Internet](#) site or [TV channel 4](#).
