Online Databases - The law library subscribes to two online databases. Westlaw and Fastcase are both accessible from specific computers in the library and there is no charge to patrons other than print costs. A photo ID is required to use library computers.

Periodicals/Law Journals - Titles are shelved in alphabetical order. Some volumes are available on microfiche.

Reference - A variety of reference materials are available, including, but not limited to: legal encyclopedias, dictionaries, laws, form books, and other useful resources.

Self-Help Materials - Nutshells contain general overviews of specific legal topics while Nolos are legal guides written for the general public. These materials are a good starting point for your legal research, but it is always wise to check for changes and updates to the laws, court rules, forms and other information contained in these books.
