Full-Length Articulated Skeleton and Stand -


The skeleton is five feet tall on a rolling stand, featuring individually inserted teeth and a three-part mounted skull. The 200 bones are calibrated to a realistic weight.

Human Eye in Six Parts –

The eye is three times natural size and dissects into the sclera, cornea, choroids, iris, retina lens, vitreous humour, and attached eye muscles.



Heart – This highly detailed two-part heart has a detachable front heart wall that reveals the chambers and valves inside.



Oversized Human Ear – The ear is three times life-size and features a removable eardrum, hammer, anvil and stirrup as well as a two-part labyrinth with cochlea and auditory balance nerve.

Sixteen-Part Unisex Torso – This model contains removable parts including a three-part head, lungs, heart, stomach, liver, gall bladder, intestinal tract, kidney and urinary bladder.



Human Heart – The human heart is twice the size of a healthy adult heart and opens via three hinged access panels to display sixty-five parts.

Brain, Giant Functional – This brain model reproduces the brain of a right-handed person, employing contrasting colors and hand-lettered captions to locate and identify motor and sensory functional centers.



Five-Part Head and Neck – This life-size reproduction of the head and neck has been sectioned into halves to display interior details of the brain, nose, mouth and throat. The eyeball, tongue, and facial bone detach.

Skull with Brain in Eight Parts - The skull features an eight-part brain that fits snugly inside the cranial cavity.



Female Torso – The female torso has a removable breast cover that reveals fourteen parts: torso, breast plate, lung, heart, trachea, and esophagus, diaphragm, stomach, liver, pancreas and spleen, bladder and uterus, and intestines.

Human Digestive System – This life-sized model comes in three parts to display the entire digestive system in graphic detail with a removable transverse colon and front stomach wall.



Deluxe Hand and Wrist - The deluxe hand and wrist is life-sized and features bones, muscles, nerves, tendons, arteries and ligaments.



Brain in Two Parts – This brain is cast from a natural specimen and medially sectioned.



Foot – The foot is cut-away on one side to reveal internal bones, muscles, ligaments and nerves.



Median Section of Head – This model is cut away to show interior location of the brain, nose, mouth, and throat.



Articulated Human Arm – The skeletal arm is attached to the scapula and clavicle.

Articulated Leg and Foot – This skeletal leg has both foot and hip attached.
