## DIRECTIONS

The Clark County Law Library is located in downtown Las Vegas, between Bridger Ave. and Lewis Ave. It is on the east side of Third Street. **Please allow additional time to find parking.**

From I-15, take the East Charleston exit. Travel east on Charleston, turn left (north) on 4th Street, turn left on Lewis, turn right on 3<sup>rd</sup> Street. Destination is on your right.

From US-95, take the So. Las Vegas Blvd. exit. Travel south on Las Vegas Blvd., turn right on Bridger Ave., turn left on 3<sup>rd</sup> Street. Destination is on your left.
