## Legal Forms in Nevada



Courts do not always provide ready-made forms for every occasion; however, several courts and agencies have prepared forms that are available online. Links to various court forms can be found on the Clark County Law Library's Legal Forms page at [www.ClarkCountyNV.Gov/LawLibrary](http://www.ClarkCountyNV.Gov/LawLibrary).

If a suitable form is not available on the Internet, it may be necessary to create a form using a sample, an outline, or instructions from another source. The library staff can suggest research material that may contain forms, samples, or information, but may not select, proof-read, or comment on, a specific form.

**Comprehensive Forms Index** – Prepared by the Clark County Law Library to provide a listing of available Nevada forms on government and agency webpages, and of sample forms in the *Nevada Association of Legal Secretaries (NALS) Handbook of Legal Forms*. **Nevada Association of Legal Secretaries Handbook of Legal Forms (NALS)** – Contains sample forms frequently used in Nevada Courts. Sample forms must be re-typed using the appropriate Court Styling. These forms are general in nature and language may be adjusted to fit your particular needs.

**Court Styling** – Court Styling refers to the required format for documents filed in a court.

**Nevada Civil Practice Manual** – Covers a variety of civil practice issues and may contain explanations and sample forms for your particular issue.

**Rules of Court** – The court rules of procedure govern the various Nevada Courts and cover issues such as the layout of court forms, calculation of days, and appellate procedure. Whether you are a lawyer, or are representing yourself, judges will expect you to know and follow all court rules. **Nevada Revised Statutes (NRS)** – State laws may include an outline or specify information to be included in documents. The NRS are available online at [www.leg.state.nv.us/law1.cfm](http://www.leg.state.nv.us/law1.cfm).

**Databases** – Databases at the Law Library can be searched for cases and language to be used within a legal document.

**American Jurisprudence Pleading and Practice Forms** – An encyclopedia of sample legal language that can be used to create legal documents.
