Recommendation: That the Parks and Recreation Advisory Commissioner approve naming the neighborhood park to be built by the Department of Aviation on the northwest corner of the realigned Russell Road and Maryland Parkway “ Siegfried and Roy Park” and recommend that the Clark County Board of Commissioners adopt that name for the park.	

FISCAL IMPACT:

None by this action.

BACKGROUND:

The neighborhood park to be built by the Department of Aviation on their land at the northwest corner of the realigned Russell Road and Maryland Parkway, has been designed, and construction is scheduled to begin in November 2005. Completion of the park is scheduled for July 2006.

The Director of the Department of Aviation has requested their park be named “Siegfried and Roy Park,” and stated the following in a memorandum to the Department of Parks and Community Services: “The significant contributions Siegfried and Roy have made to the Las Vegas community in the more than 30 years they have lived and worked here, both charitable and cultural, are legion. Their spectacular mega-productions raised the bar for Las Vegas entertainment and created attractions unduplicated anywhere in the world. They have given unselfishly of their time, talents, and means to many causes, including conservation of rare and endangered animals, public education, 9-11 disaster relief, the USO, Golden Rainbow HIV/AIDS care, and Friends of Las Vegas Police K-9s, among others. Siegfried and Roy have come to symbolize Las Vegas to people the world over, and we would be pleased to pay tribute to their lasting legacy by naming this park in their honor.”

Pursuant to Clark County Code 19.06.060 (b) and (c), the Parks and Recreation Advisory Commission is asked to act in an advisory capacity on this matter requested by the Department of Aviation.
