<p><i>RecTrek Winter Track Break</i> program ends on April 11th. Registration for <i>Spring Break Day Camp (April 14-18)</i> and <i>Spring Track Break (Jan. 6 - June 4)</i> will be available at a later date. Please see the front desk at Desert Breeze for Spring Track Break and Day Camp registration information.</p>	

Day Camp is extremely popular and available space in the program fills quickly. Registration will be processed on a first come, first serve basis. Mail-in registration that is postmarked before the mail-in date will be returned. Drop-in daily registration is accepted if space is available.

What parents need to know?

- Day Camp is for children ages 6 – 12
- Day Camp hours: Monday – Friday from 7:00 a.m. – 6:00 p.m.
- Participants are required to bring a lunch and two snacks that do not need heating or refrigeration.

What does it cost to join Day Camp?

- \$15 per day or \$70 per week, per child
- There is a 50% discount for the third child if enrolling three siblings for the same full weeks
- CCAP assistance is available to those who qualify.
- A late fee will be assessed for children picked up after 6:01 p.m.
- **Refunds for Day Camp will be issued if notice is given by Wednesday of the prior week.**
- Transfers or credits towards other program days will not be given if the request is received after the Wednesday deadline.

What can my child do at Day Camp?

- Paint, draw, and make crafts
- Play sports, group games, and have free time in the gymnasium
- Enjoy movies and team building contests
- Have fun with friends

How do I reserve a spot for my child?

- Payment in full is required to reserve a spot.
- Please be sure to include your **driver's license number** on the top of your check

That's a lot of money up front. Do I have any payment options if my child will be attending the entire winter track break?

Yes. Participants who will be attending full consecutive weeks may reserve their spot by paying for the first two weeks up front. Payments for the remaining weeks must be paid by 6pm Wednesday of the prior week.

How do I get a print out of my childcare expenses at the end of the year for TAX preparation?

Beginning this *Winter*, parents will be able to access and print out their payment totals online via the online registration system. ****Please be sure to include your email address to ensure staff can assist your family with an online account to access this new feature.**
