- Registration cannot be accepted by phone.
- Classes not reaching minimum enrollment will be cancelled and fees will be refunded by check (no refunds to credit cards) or credited to your account.
- Forms that are not filled out completely will be returned.

**Refunds:**

**Clark County prohibits the disbursement of immediate funds.**

Refunds are processed through the Clark County Treasurer's Office and it may require four to six weeks to complete the transaction. Credits can be issued to your account with Clark County Parks & Recreation for future use.

If a class, program or rental is cancelled by Department – a Full Refund will be issued (100%).

If class registration is cancelled by the individual, refunds are to be issued as follows:

Prior to the close of business first day of the class	100%
After the first day of class	NO REFUND
