Please note: Walk-in registration will only take place at the Safekey Administration Office, located at 2601 E. Sunset Rd., Las Vegas, NV 89120, beginning at 7am.

Online Registration: Monday, April 2, 2018 (space permitting)

The Safekey Summer Camps are extremely popular, please remember space is limited. Registration is processed on a first-come, first-serve basis or in the order received.

What do parents need to know?

- Safekey Summer Camps are designed for children ages 6 - 12(may be age 5 if kindergarten has been completed)
- Camp hours: Monday – Friday 7:00A.M. - 6:00P.M.
- Participants are required to bring two snacks that do not require heating or refrigeration.
- BREAKFAST & LUNCH will be provided.
- Summer Camp sites are open to all students with no zoning restrictions.
- All parties must follow the parent/Participant Guidelines, no exceptions.

What does it cost to join the Summer Camp?

- A one-time \$5 per child program fee (t-shirt)
- \$18 per day per child or \$85 per week per child.
- Field trips may be offered at an additional fee. Participants attending field trips must wear a Summer Camp t-shirt.
- We accept CCAP (Las Vegas Urban League). Contact Safekey Office for details.
- Children picked up after 6PM, will be assessed a late fee of \$5 for every 10 minutes beginning at 6:01 PM.

What can my child do at Summer Camp?

- Paint, draw, make crafts, theme projects
- Play sports, games, field trips
- Enjoy skits, drama, movies, and water day
- Have fun meeting new friends.

How do I reserve a spot for my child?

- Payment in full is required to reserve a spot.
- Day Camp availability is based on a first-come, first-served basis.
- We encourage you to pay for the days you will be attending in advance.
