

ELECTION DATES

Federal/State Elections are in even-numbered years. Below are specific dates for this years elections:

January 17, 2014—Last day for Judicial candidates planning to run for office in Clark County in 2014.

January 2 - February 6, 2014—Independent Candidate petition of candidacy to appropriate filing officer.

January 6-17, 2014—Period for judicial candidates to file for State Supreme Court, District Court (including Family Division) and Justice of the Peace.

January 18 - March 14, 2014—Pre-registration for non-judicial candidates running for office in Clark County in 2014.

January 29, 2014—Last day for name changes, withdrawal or rescinding withdrawal of judicial candidacy.

March 3-14, 2014—Period for non-judicial candidates to file for office.

March 25, 2014—Last day to withdraw or rescind withdrawal of candidacy for non-judicial candidacy.
