If your household income was less than \$50,000 in 2011, you can receive **FREE** tax preparation and may be eligible for a refund of up to \$5,751 with the Earned Income Tax Credit.

What do you bring?

- ☐ Valid identification (valid Driver's License or photo identification)
- ☐ Social Security cards or Individual Taxpayer Identification cards for you, your spouse, and your dependents
- ☐ All 2011 W-2 and 1099 forms you received
- ☐ Daycare payment records
- ☐ Any other tax documents
- ☐ Optional: voided check for direct deposit
- ☐ If filing jointly, both spouses must be present
