 - a. IL Updates
 - i. Up and coming workshops (Winter Break)
 - 1. Food Handler's card training (Charles Prater and Kathy Treants)
 - a. Coming up on the Dec. 21st, registration is full
 - b. Recap,1st session, Nov's went well.
 - i. Kathy and Charles did a great job facilitating the workshop along with other IL staff.
 - ii. Most of the youth passed their test, received gift cards and their voucher to pay for the health card
 - 1. Despite youth receiving their 30-day voucher many did not make it within the 30 day window to pick up their health card.
 - 2. IL will be following up with the youth that were not able to get their card and or voucher.
 - 3. IL will have vouchers ready before the workshop, youth have 30 days from the day of the workshop to get to Southern Nevada Health District.
 - 4. Need everyone's help, reminding youth and getting them to Southern Nevada's Health District.

5. Clark County Social Services (Step Up)

- a. Currently have 315 young adults participating in Step Up
 - i. 15 FAFFY and 300 Voluntary Jurisdiction
 - ii. Since this is the last month of the year, we have had 92 young adults enter and 94 young adults exit
 - iii. Currently doing interviews for an Office Specialist.
 - iv. Things are still going well with Guide Tree implementation
 - v. Staff Lisa Julia and Jenn, have taken on Step Up Plus, done the training and enrolled some guide tree participants

- a. Shining Star Mason
 - i. Child haven IL classes ongoing
 - ii. Working with Juvenile detention center
 - 1. Teaching a Nutrient Classes
 - 2. Working on implementing a hybrid program- Packaged IL Module for JDC
- b. Rise Home -Daia
 - i. Will start deploying our assistance with rental assistance and emergency shelter starting in Jan.
 - 1. Rental assistance
 - a. Help with move in or rental deposit
 - b. Can only help with one month rent
 - i. Just need a sign off from landlord.
 - 2. Emergency Shelter
 - a. For youth in-between housing or services. Need a place to stay temporarily
 - b. Place hotel/motel voucher
 - i. Pay for up to 30days
 - ii. Women's home for transitional living program.
 - 1. 6 beds (taking 18 or more young people)
 - iii. For Assistance contact Daja@risehomesnv.com
- c. Olive Crest -Alissa
 - i. Teens and young adults' program that cater to current and former foster youth
 - 1. Servicing young adults ages 18 to 21yrs
 - 2. Providing independent living as well as placement in one of their apartments
 - a. Currently have 3 vacancies with 1 geared towards a single mother

- 3. Opening therapy services for current and former foster youth who aren't in their care
 - a. Providers they can assist with are Medicaid fee-for-service and Molina
- ii. Question from Laura, NSHE
 - 1. Does your process require a youth to go through the coordinated entry process or is their process separate?
- iii. Answer from Alissa
 - 1. Olive Crest has their own application process.
 - a. Application is given to the youth, have youth fill it out and get it back to Olive Crest.
 - b. Alissa will review it. If a child is in therapy, they will ask for the assessment, if not they will get a mental health assessment done at Olive Crest
 - c. Review the assessment to make sure if they can assist and how to support the needs of the individual long term
 - 2. Young adults are required to either be working or attending school
 - 3. Rent at a reduced rate
 - a. \$550 a month, \$450 goes to cable, Wi-Fi, and utilities the other \$100 goes into a savings account to them
 - b. Will match up to \$2400 if they are in the program that long and successfully complete the program
 - c. On a very rare occasion they are able to keep youth past the age of 21
 - 4. Alissa agreed to email Laura more information.
- d. NSHE-Laura
 - i. Just did an overhaul of our financial aid tool kit on their website
 - 1. Updates to scholarships and other resources and subheading for youth that have been in foster care
 - a. ETV information and Scholarships both locally and nationally
 - b. Applications are due at various times of the year for scholarships (heavy season is now through the first quarter of the year)

 - 2. Community Foundation Northern Nevada
