

# 2026 ELECTIONS

I, LORENA S. PORTILLO, the duly appointed Registrar of Voters of Clark County, Nevada, do hereby certify that the following State, District, County, Town Advisory Board, and Township offices are the offices for which candidates are to be nominated at the Primary Election to be held on the 9<sup>th</sup> day of June 2026, in Clark County, Nevada.

**Judicial candidate filing will be conducted January 5<sup>th</sup> through January 16<sup>th</sup>, 2026.**

**Non-Judicial candidate filing will be conducted March 2<sup>nd</sup> through March 13<sup>th</sup>, 2026.**
