ADAMSHEART RECOGNIZED FOR DONATION OF LIFE SAVING DEVICES

Commissioners Michael Naft and Justin Jones recognized The Adamsheart Foundation for their donation of six Automated External Defibrillators (AED's) to James Regional Sports Park. The defibrillators will be installed on light poles throughout the complex.

"It is possible to have a cardiac event whether you have a pre-existing condition or not," said Commissioner Michael Naft. "When a cardiac arrest happens, the time it takes to get and use an AED on a victim directly impacts their chance of survival. The addition of more units at these two facilities will reduce the time it takes to save a life. I am grateful for the generous support of Adamsheart and all those who have made the availability of these lifesaving defibrillators possible."

Recently, Clark County Commissioner Michael Naft held a **Curbside Care** event that offered free services to the public in the **Silverado Ranch** neighborhood. The event featured car seat checks, medication disposal, electronics recycling, and COVID-19 and flu shots. It was made possible thanks to the partnership of the Las Vegas Metropolitan Police Department's Enterprise Area Command, the Blind Center of Nevada, Clark County Fire Department, Clark County Parks and Recreation, The Car Seats for Christy Foundation, and others.

This September, District A hosted **Coffee and Conversation** in the south County towns of Searchlight, Cal-Nev-Ari and Laughlin. Residents were invited to provide input and ask questions about Clark County, its departments and agencies.

Commissioner Naft also recognized **The Searchlight Betterment Organization** for the revitalization of their flag pole box, attended meetings with local businesses, and rode along with the **Nevada Department of Wildlife** to gain a better understanding of how the Colorado River is patrolled and how we may improve safety on the water.



COMMISSIONER NAFT GIVES SPECIAL RECOGNITION



A special presentation took place at the September Board of County Commissioners meeting. Commissioner Michael Naft recognized philanthropist Justin Woo, whose donation made possible an in-depth DNA investigation and helped solve the 1989 Las Vegas cold case murder of 14-year-old Stephanie Issacson. Stephanie's father, John Issacson, was in attendance and met Justin Woo for the first time. He thanked him for his efforts, which led to much needed closure for the family.

Commissioners also recognized Nevada Task Force 1 for its efforts during their deployment to Hurricane Ida's hardest-hit areas. They conducted hundreds of searches and evaluated infrastructure damage while in Louisiana.

OVERDOSE AWARENESS DAY OBSERVED IN CLARK COUNTY



County Commissioners and representatives from **Moms Against Drugs** and **The Drug Epidemic Awareness Walk Across America** turned the Welcome to Fabulous Las Vegas sign purple in recognition of International Overdose Awareness Day.

"Drug overdoses are the leading cause of accidental deaths for Americans under the age of 44. "Every one of these deaths is a tragedy that could have been avoided, which is why it is so important to let those struggling with substance abuse issues know that help is available," Commissioner Michael Naft said.
